Peterson moved, Doepcke seconded the appointment of Courtney Vorwald to the position of Assistant Clayton County Attorney, an exempt position, at a wage of \$90,000.00 per year, effective immediately. Ayes: Doepcke, Peterson, Reimer. Motion carried.

Information Technology Help Desk Technician Garrett Baumgartner provided a departmental update.

Doepcke moved, Peterson seconded to approve a contract with IP Pathways for network engineering services. Ayes: Doepcke, Peterson, Reimer. Motion carried.
